## 三、人选条件

- 1. 拥护中国共产党领导,热爱祖国,具有良好的思想品德和政治素质,无违法违纪记录。
- 2. 具有良好专业基础和发展潜力,在工作中表现突出, 具有学成回国为祖国建设服务的事业心和责任感。

- 3. 具有中华人民共和国国籍,不具有国外永久居留权。 申请时应为国内高等院校、高等职业院校在职英语教师,年龄 不超过45周岁(1974年1月1日以后出生)。
  - 4. 身体健康, 心理健康。
- 5. 具有英语教学工作经历,具有英语专业本科学历、学位证书。
- 6. 雅思成绩不低于7分或托福成绩不低于98分(有效期内,不晚于2021年3月前提交)。

## 四、申请办法

- 2. 国家留学基金委委托各受理单位负责申请受理工作。 有关高校负责受理本校在职人员的申请,其他人员的申请由有 关国家留学基金申请受理机构负责受理,国家留学基金委不直 接受理个人申请。
- 3. 各受理单位应对申请人提交的材料进行审核,对拟推荐人选进行公示后,于2020年11月13日前将推荐函、推荐人员名单(需按优先推荐顺序排序)及纸质对外联系材料统一寄送至国家留学基金委欧亚非事务部,将电子对外联系材料邮件发送至ouyafei7@csc.edu.cn。逾期将不予受理。
